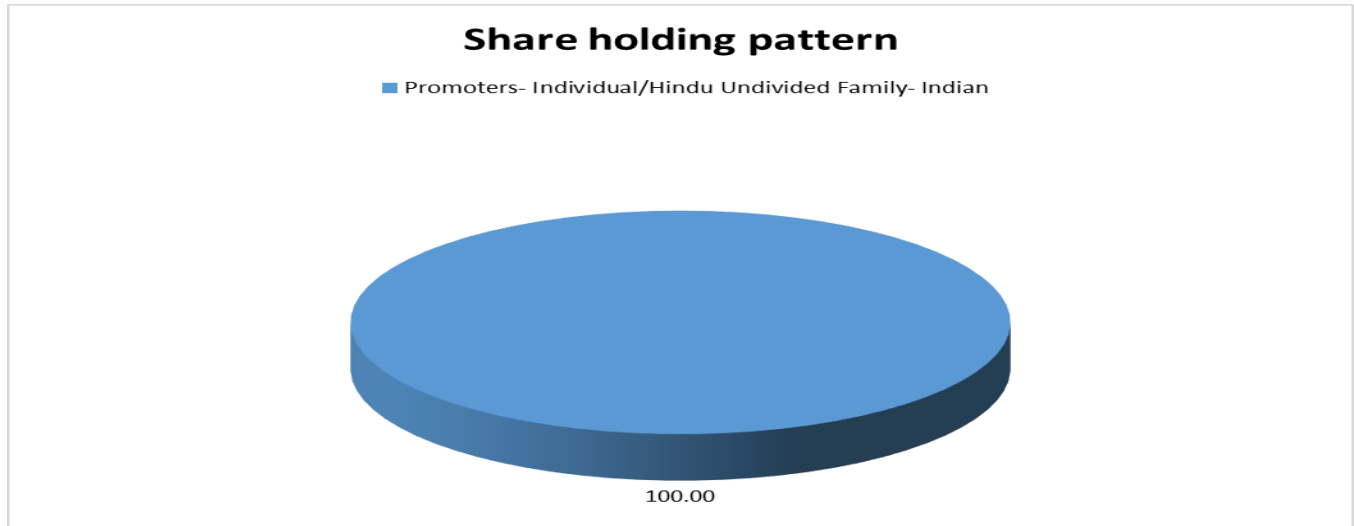

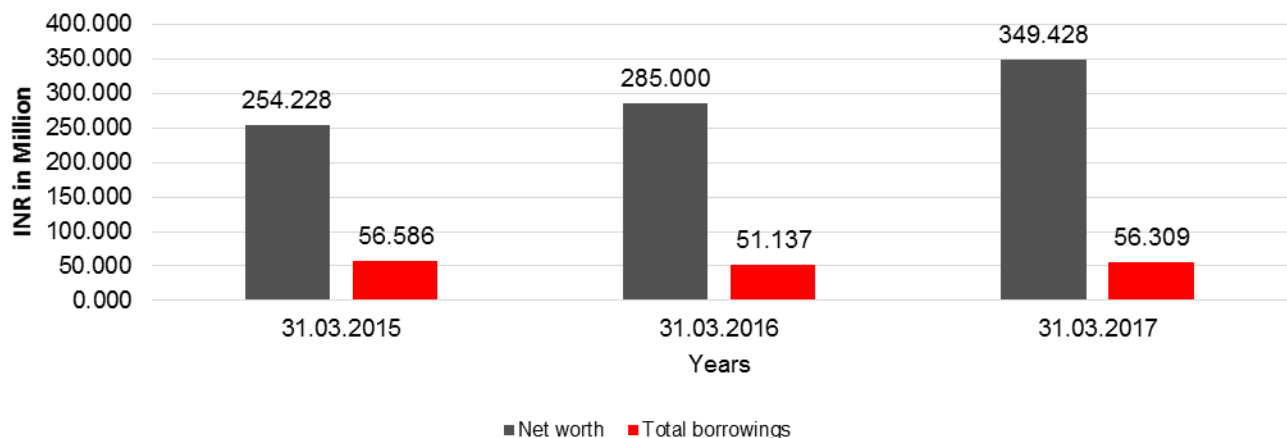

**Debt to Equity**



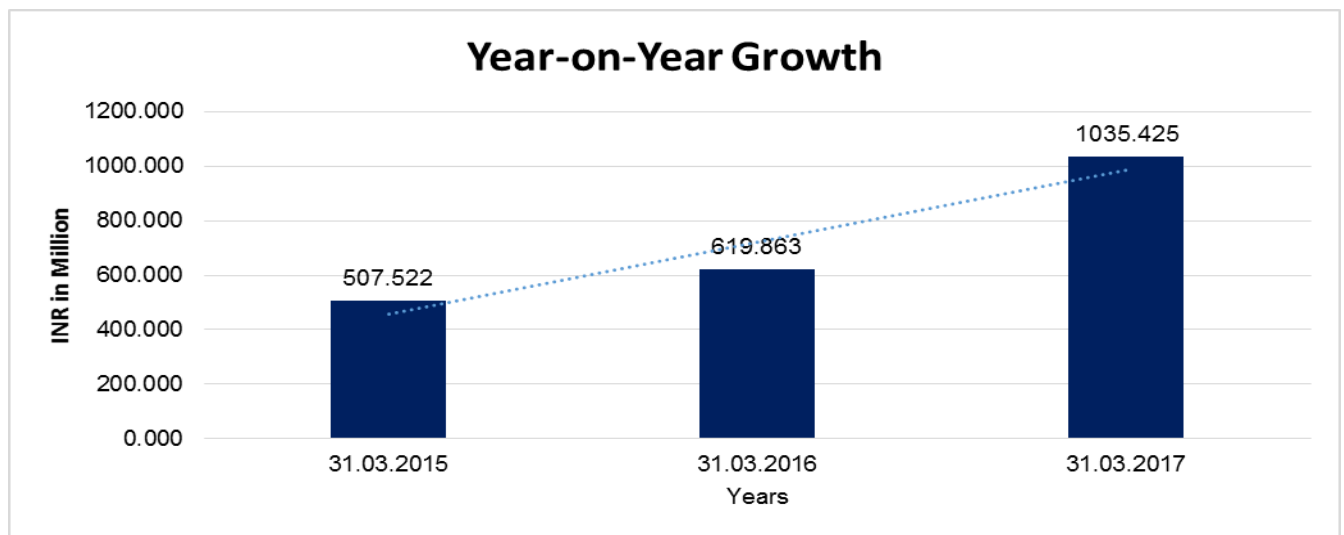

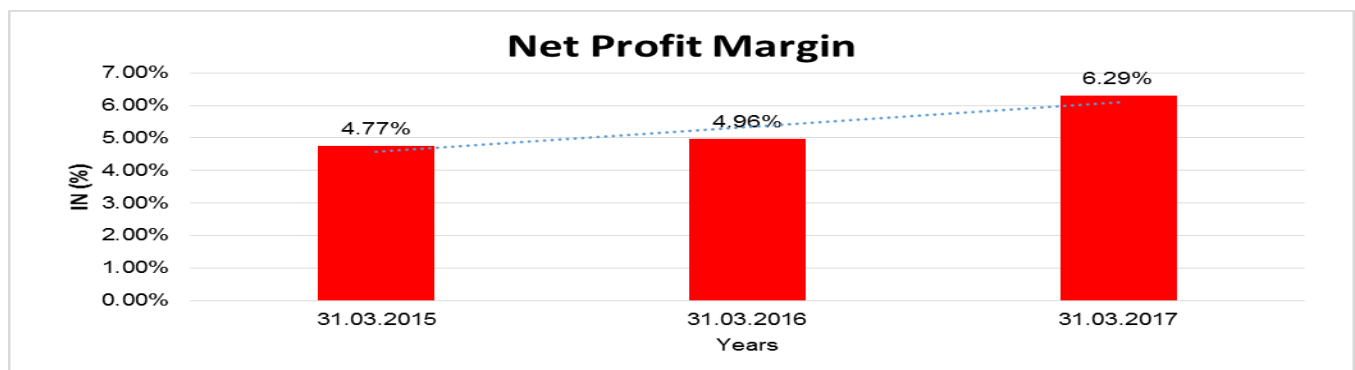
