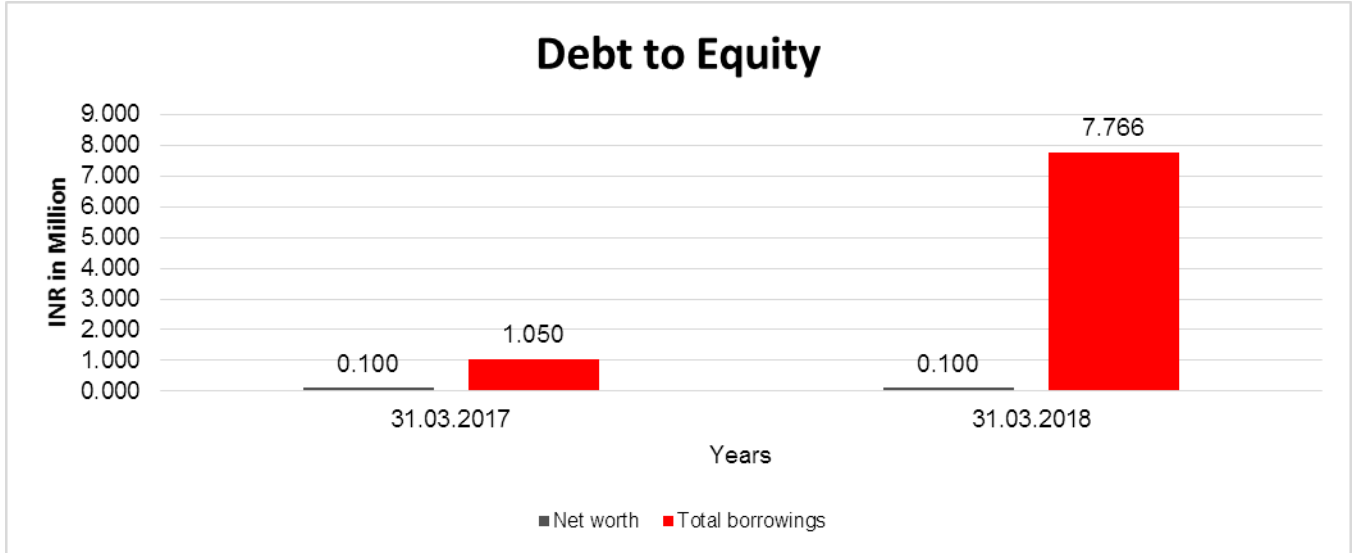

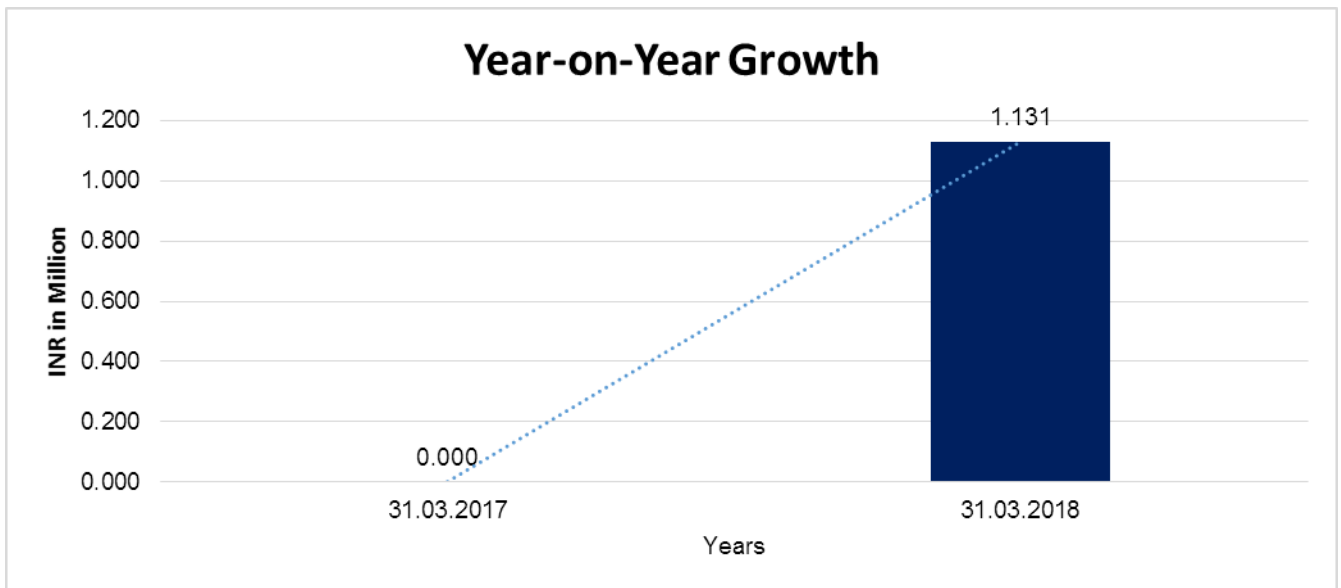

YEAR-ON-YEAR GROWTH

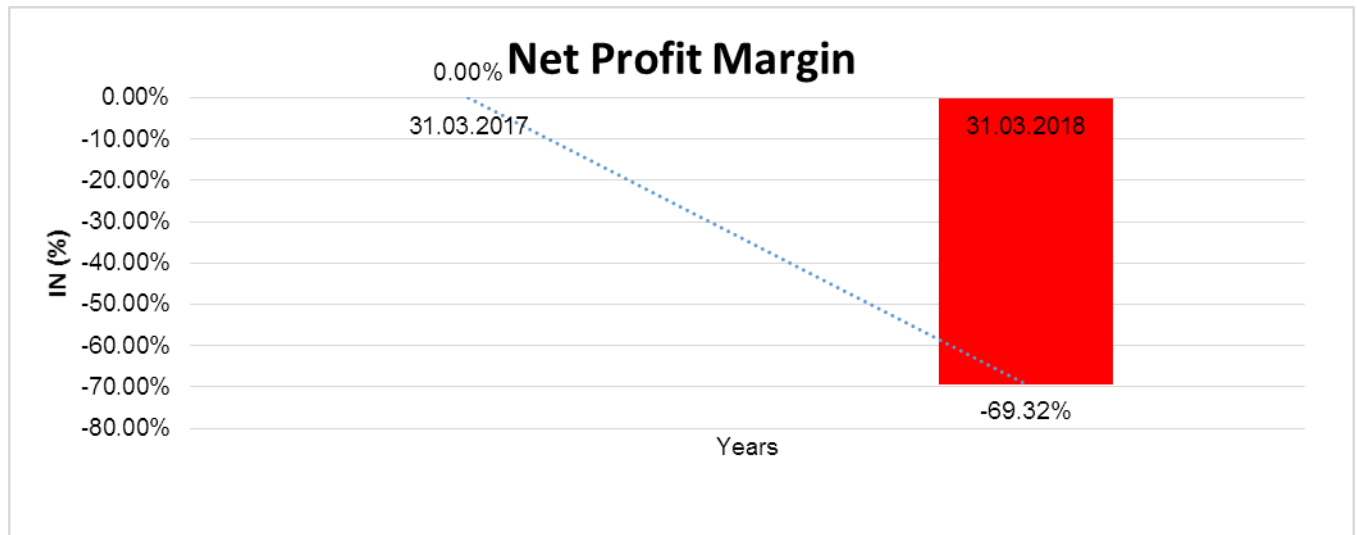
